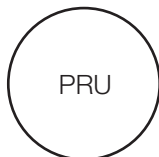

## Terms and Conditions

1. By submitting this application, I authorise Standard Chartered Bank to disclose all the information herein to Prudential.

If no such policy exists or no premium is due on such policy, the Reward points will be reinstated into your Prudential Platinum Card Account. For the purposes of these terms and conditions, "Family Members" shall mean your spouse, children, parents, parents-in-law, brothers and sisters.
